## **Items for Consideration**

- 1. <u>Council Minutes</u>: The City Council approved the minutes of the February 9, 2021 Regular Meeting, as amended.
- 2. <u>Construction Contract Award</u>: The City Council continued this item to March 9, 2021.
- 3. <u>Final Map Approval</u>: The City Council authorized the Interim City Manager to execute the Subdivision Improvement Agreement and approved the Parcel Map for 831 Arroyo Road.
- 4. <u>Final Map Approval</u>: The City Council authorized the Interim City Manager to execute the Subdivision Improvement Agreement and approved the Final Map for Tract #10553, 450 First Street.
- 5. Ordinance No. 2021-475 Hillview Baseball Field Off-Leash Dog Pilot Program: The City Council adopted an ordinance establishing an off-leash dog pilot program located at the Hillview Baseball Field and making findings pursuant to CEQA that the ordinance is categorically exempt from environmental review, as amended. This pilot program allows dog owners to have their dogs off-leash during specific posted days and times.
- 6. 140 Lyell Street (VTTM 19-003; DR 19-007: The City Council approved, per the Planning Commission recommendation, a five-unit condominium project at 140 Lyell that includes permits from the City of Los Altos including, but not limited to: a vesting tentative map and a design review approval permit. The City has determined that the project is exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15332 of the CEQA Guidelines.
- 7. <u>Update of Emergency Measures for Addressing COVID-19</u>: This item was deferred for this Council meeting.
- 8. Resolution No. 2021-08: Business License Payment Deadline Extension: The City Council adopted Resolution No. 2021-08 authorizing the extension of the deadline to pay Business License Tax for 2021 to September 30, 2021.
- 9. <u>Resolution No. 2021-09: City Council 2021 Goals</u>: The City Council adopted Resolution No. 2021-09 setting the City Council's 2021 Goals.
- 10. <u>Community Center Construction Monthly Update</u>: The City Council received a presentation from the Engineering Services Director and staff on the Community Center Construction Monthly Update.

11. <u>330 Distel Circle</u>: The City Council received a brief update from the Community Development Director on the 330 Distel Circle affordable housing project.
