### CALL TO ORDER

**Roll Call:** present were Scott Chan, Bill Crook, Carl Hagenmaier (Chair), Chris Hlavka, Henry Pastorelli, Randy Rhody and Larry Lind (city staff)  
Absent was Curt Riffle (Chairperson)

### Public Comments:

### Discussion:

1. Approval of October 18, 2006 BPAC meeting minutes (Carl) (Decide)  
Add that Dan Collen clarified that reference was to pedestrians walking on the roadway (paved surface). Moved, seconded and approved.
2. VTA BPAC update (Carl) (Inform)
  - County Roads presented to the BPAC. Several BPAC members were quite hostile to their presentation.
  - County Roads is proposing to create a county BPAC. Currently the VTA BPAC performs this function.
  - They will re-open Community Design and Transportation Planning grants in spring or summer. There is \$3M still available.
  - Sunnyvale is considering extending Mary Av over 101 to provide access to a very large office complex at Moffett Park
  - To get MTA funds for a bicycle project, the relevant bicycle plan should be current within 3 years. Not clear if this is an absolute requirement.
  - Michelle is looking for the remainder of funds for SCT feasibility study.
3. Traffic Commission update (Bill) (Inform)  
Nothing significant to report from last meeting. 11/30 meeting will review SRTS proposal prior to submission to council.  
  
Action item for Scott to contact Susan Kitchens re BPAC opening.
4. Stevens Creek Trail Feasibility Study (Randy, Henry) (Discuss)  
A brainstorming meeting was held 11/1. Minutes were posted on the Yahoo group for the task force. Next task force meeting is 12/7. Randy suggested that next meeting should clarify the

task force membership, formalize the roles and purpose of the task force. 12/7 meeting does not need to be noticed as no more than 3 BPAC members will attend.

There was discussion about how (and whether) to take the roles/membership to city council. The BPAC suggested that the task force should consider formalizing their meeting rules in the next meeting.

Larry reported that interviews will take place on 11/20 to pick one of the three consultants who responded. Larry, Tom Ho, and Jim Porter will interview.

5. Adobe Creek Bridge replacement project (Larry) (Inform)  
100% design coming up in next couple of weeks.
6. Update on Council priorities (Bill) (Inform)  
Council authorized city to contract for San Antonio embedded lights. Still in “above the line”: Stevens Creek Trail feasibility, safe routes to school, bicycle racks, Springer/Fremont ADA improvements, and Garden House lift. Don’t consider these comments as firm.
7. Garden House ADA (Larry) (Discuss)  
100% was in but rejected by Terry Greiner.
8. Prioritization of ADA projects (Chris) (Decide)  
Bill moved that we accept Chris’s recommendation of revised ADA project priorities, and forward it to Traffic Commission with the recommendation that TC send it to city council. Motion was amended to re-order St Joseph Av before Garden House Phase II?
9. Which 2007 projects for BPAC to review  
We requested that Larry bring to the next meeting the plans for the next round of repaving projects. Larry said he would bring in a list of streets he intends to slurry seal.
10. Parking in bike lanes  
Carl will contact the parking enforcement officer, Sayers, to suggest that he enforce the no parking on Edith and decide what is the best way to deal with this.
