

# **BICYCLE/PEDESTRIAN ADVISORY COMMITTEE MINUTES**

#### CALL TO ORDER

#### Discussion

1. Minutes of October 19, 2005 were approved.

2. Stevens Creek Trail Update (All)

Randy presented a proposed timeline for getting the feasability study approved. Bill cautioned that the city has no real commitment to the study, and that the extra \$1.6M required for the county fire protection will put the budget slot at risk. Discussion about whether the VTA funds "expire" in September, 2006. Conclusion is that there is no solid answer but probably the funds don't go away.

Mountain View will break ground to go under El Camino this year, a 12-18 month project. Second stretch to planned overpass at Sleeper Avenue. Third part over creek twice to MVHS. Estimated all the way to MVHS 2010–2012. Terminates at Bryant (at a vacant lot). Mountain View experience 1 or 2 years to plan and 1 or 2 years to implement. Last stretch to MVHS 2 years study, 1 ½ year discussion. Mountain View Reach 4 study was \$250K (estimated, Nolte Associates).

Cupertino (easement across railroad) Rancho San Antonio to Stevens Creek Blvd. Stevens Creek Blvd to McClelland Ranch via Blackberry Farm. Second part starts 2007 (completion 2009?). The only connection to Los Altos would be through Rancho San Antonio to St Joseph Avenue. Cupertino had community involvement sessions for section from Stevens Creek Blvd to McClelland Ranch.

### Marketing:

School access: Cupertino under 280 to Montclaire. Montclaire area + triangle to West Valley Elementary, Cupertino Middle School, Homestead High.

Traffic calming in South Los Altos

Funding sources: 49er foundation? Google, Los Altos Community Association, FSCT. Summary:

## Marketing:

- De-emphasize Stevens Creek Trail. Emphasize traffic calming, schools, "South Los Altos school corridor", etc.
- Break it into two segments: each side of Fremont Av. (Randy and Henry will work on this idea and in the next meeting suggest an answer to "How to approach the council?")

City funding is in jeopardy, consider alternative sources, so we should study alternative sources. (Curt will work on)
