Los Altos Community Center Campus 2012 Bond Measure Feasibility Survey

April 2012

Overview and Research Objectives

The City of Los Altos commissioned TBWB Strategies and Godbe Research to conduct a survey of local voters with the following research objectives:

- Assess potential voter support for a bond measure to replace the deteriorating and inadequate Hillview Recreation Center; build an earthquake safe police station and emergency operation center; and complete related infrastructure improvements;
- Identify the optimum tax amount at which voters will support the measure;
- Prioritize projects and programs to be funded with the proceeds;
- Test the influence of supporting and opposing arguments on potential voter support; and
- Identify any differences in voter support due to demographic and/or voter behavioral characteristics.



Methodology Overview

- Data Collection Telephone Interviewing
- Universe 12,212 likely August 2012 mail ballot voters voters in the City of Los Altos, with a supplemental sample slightly lower propensity voters.
- Fielding Dates March 22 through March 27, 2012
- Interview Length 18 minutes
- Sample Size 404 likely August 2012 mail ballot voters and supplemental sample voters
288 likely August 2012 mail ballot voters
- Margin of Error $\pm 4.8\%$ likely August 2012 mail ballot voters and supplemental sample voters
 $\pm 5.7\%$ likely August 2012 mail ballot voters

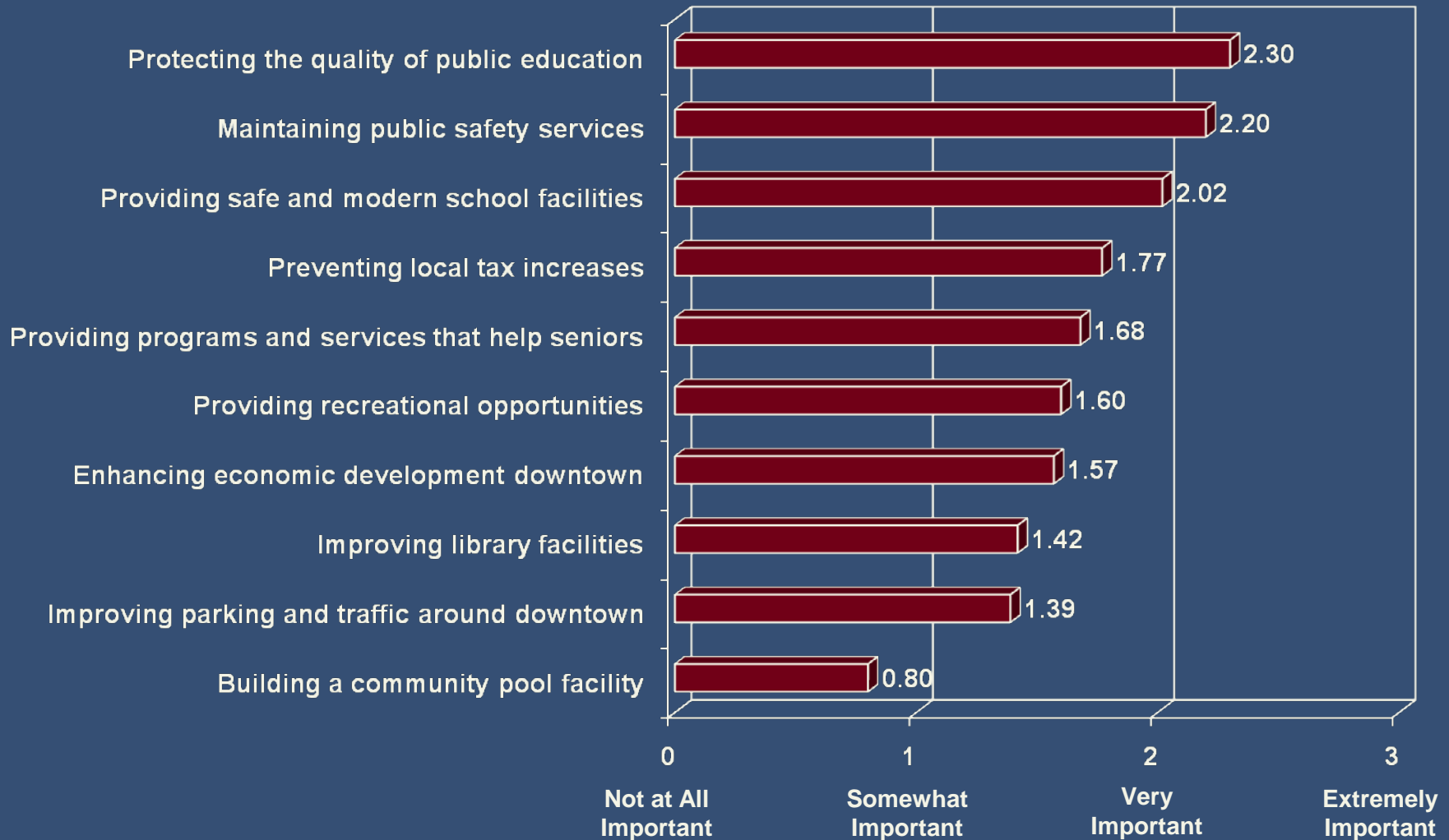

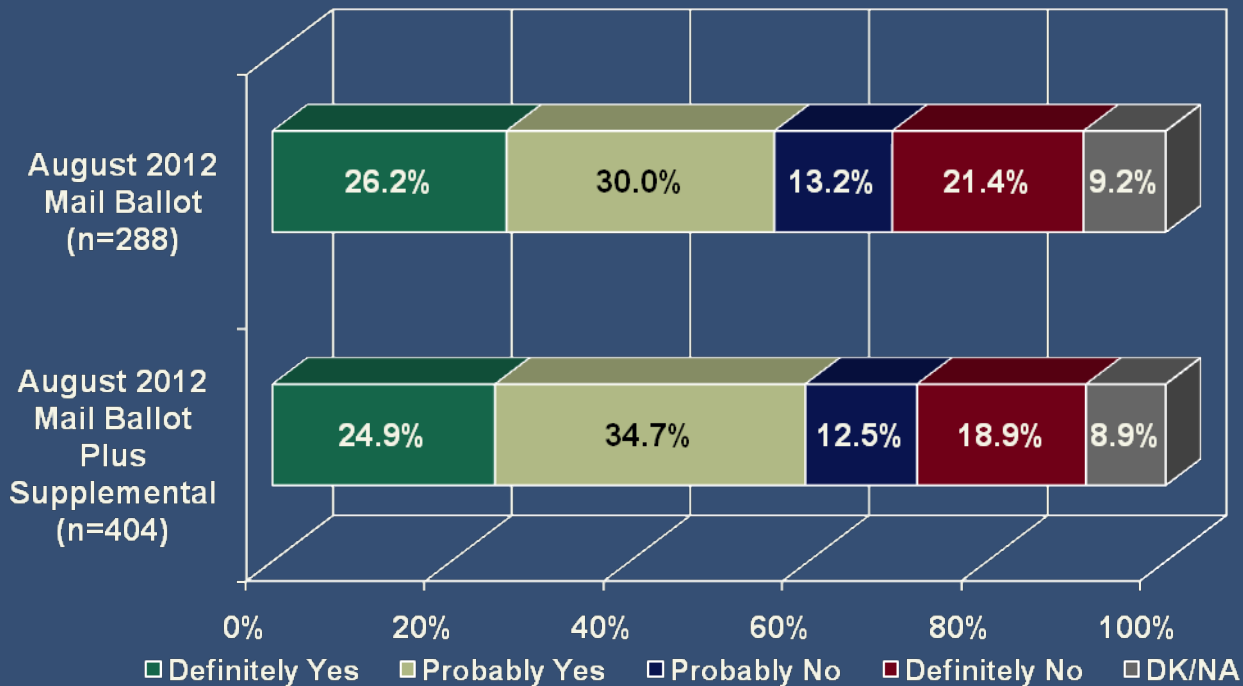
Key Findings

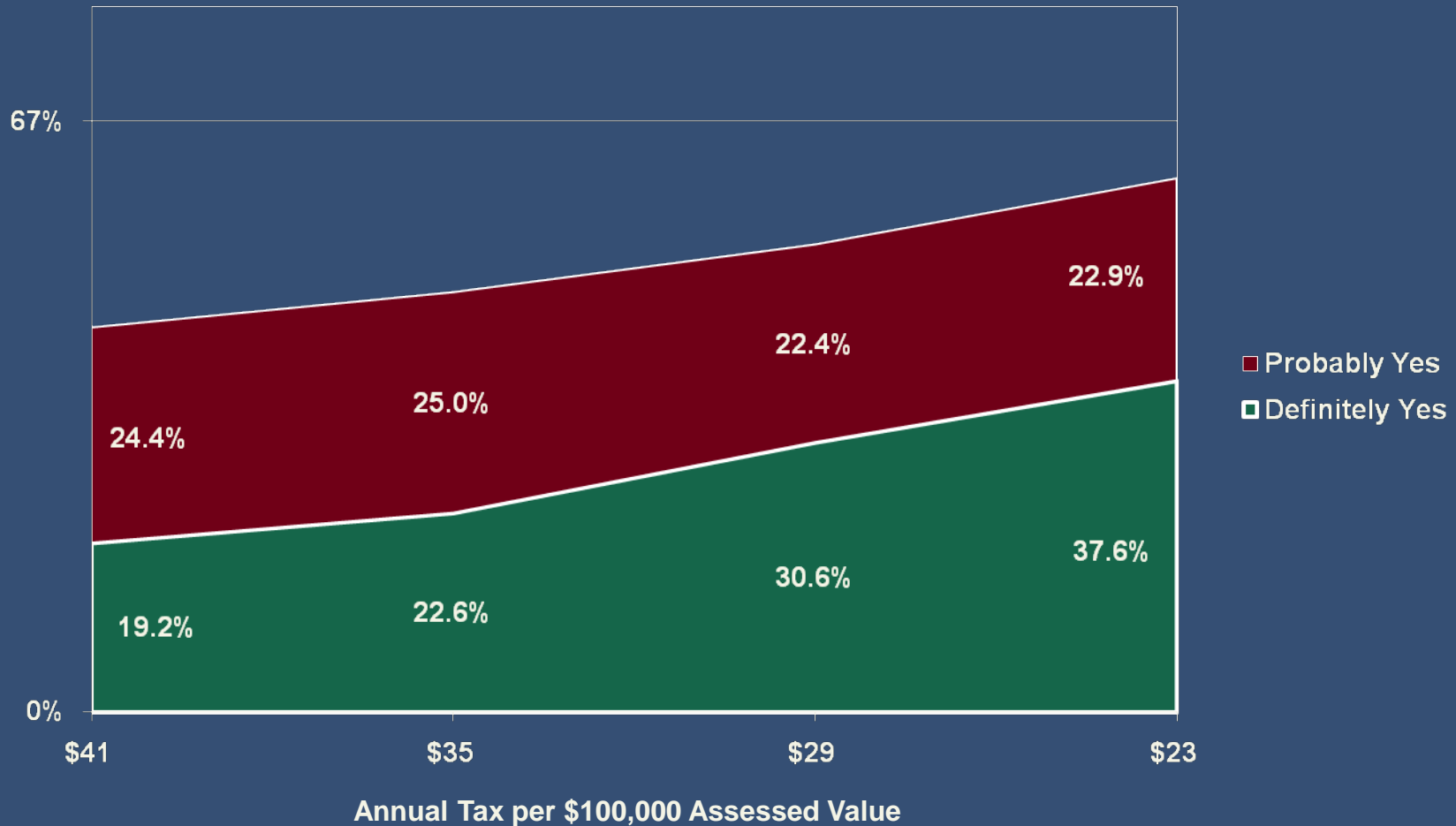

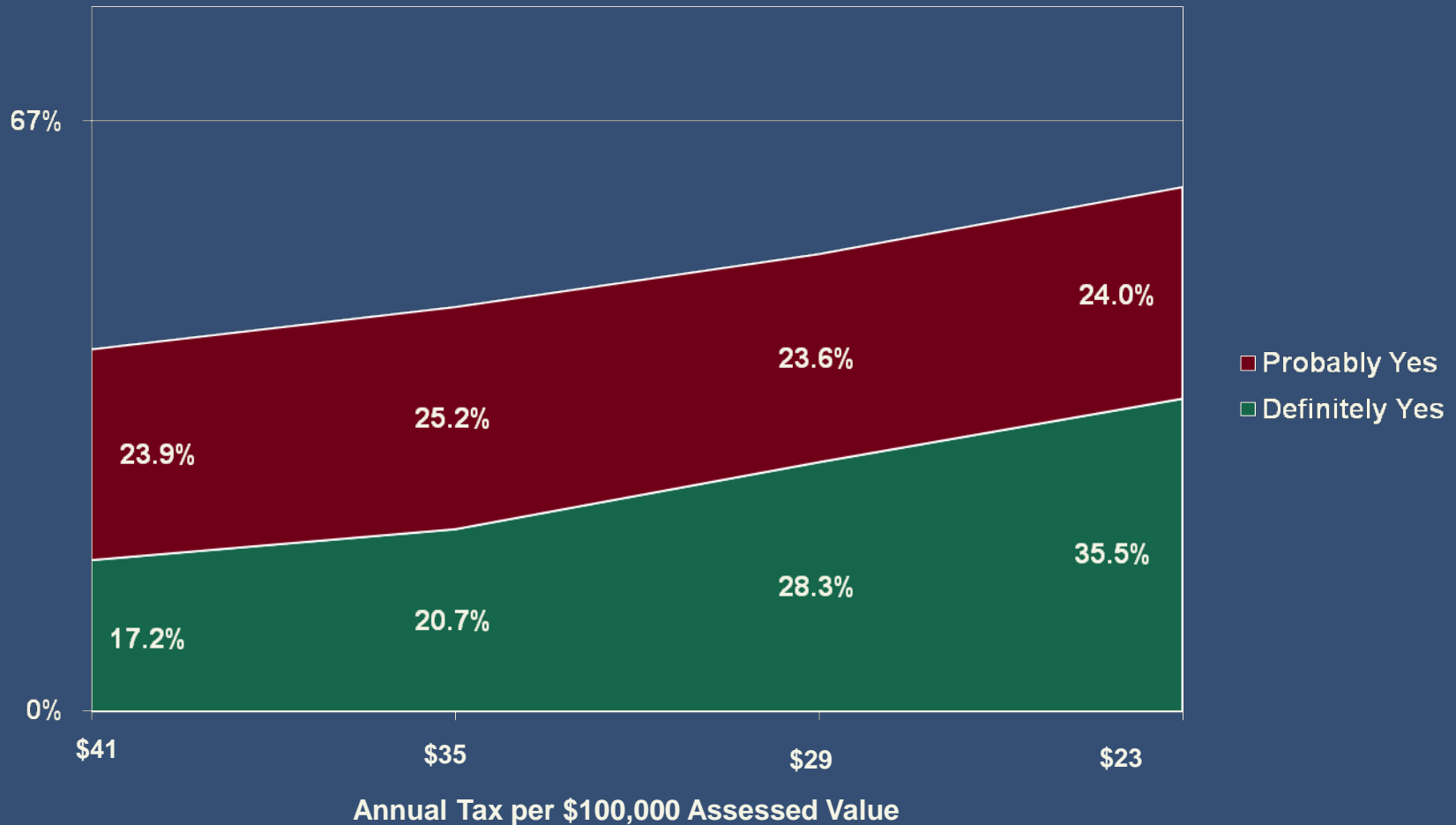
August 2012 Mail Ballot (n=288)



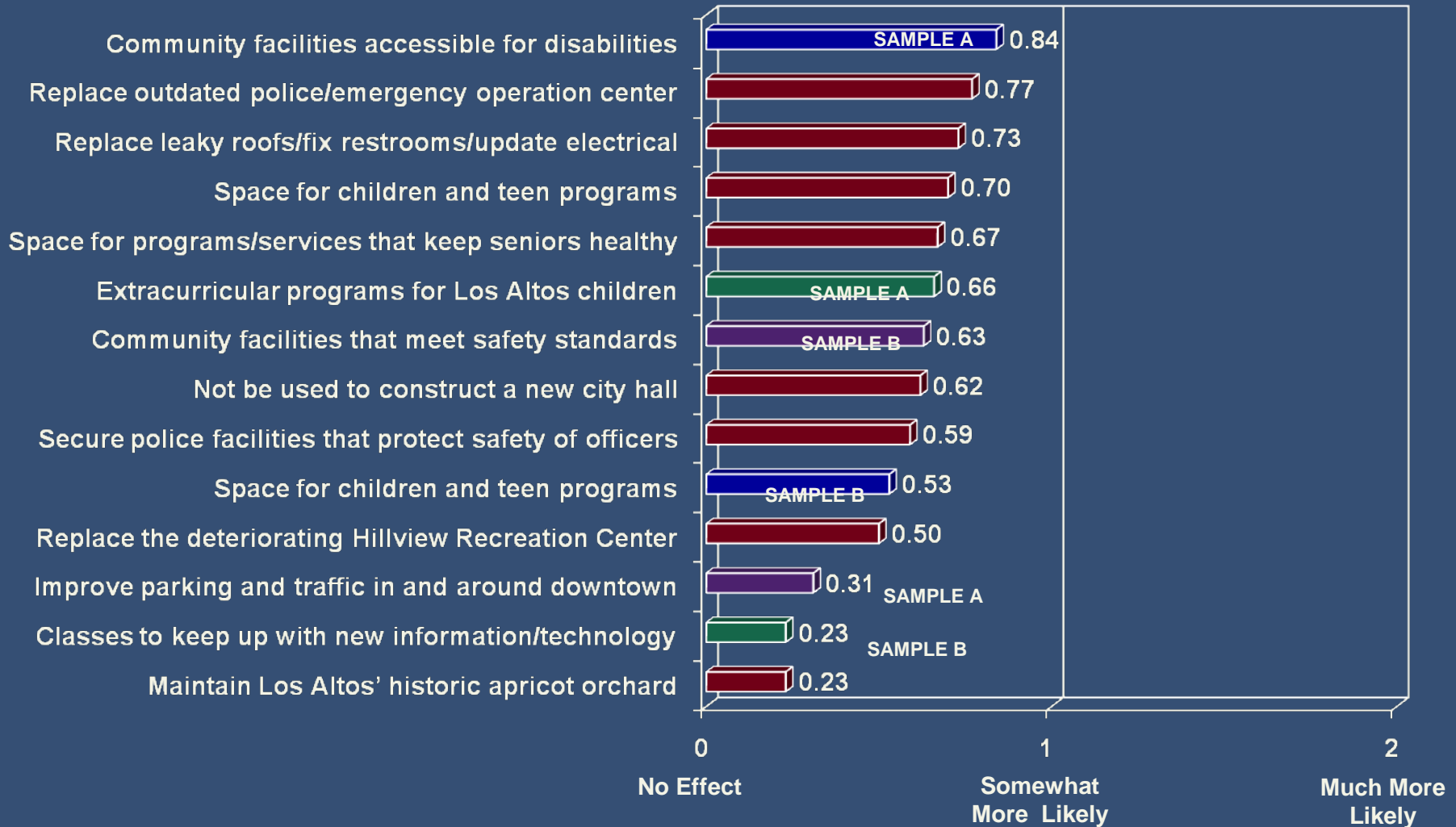

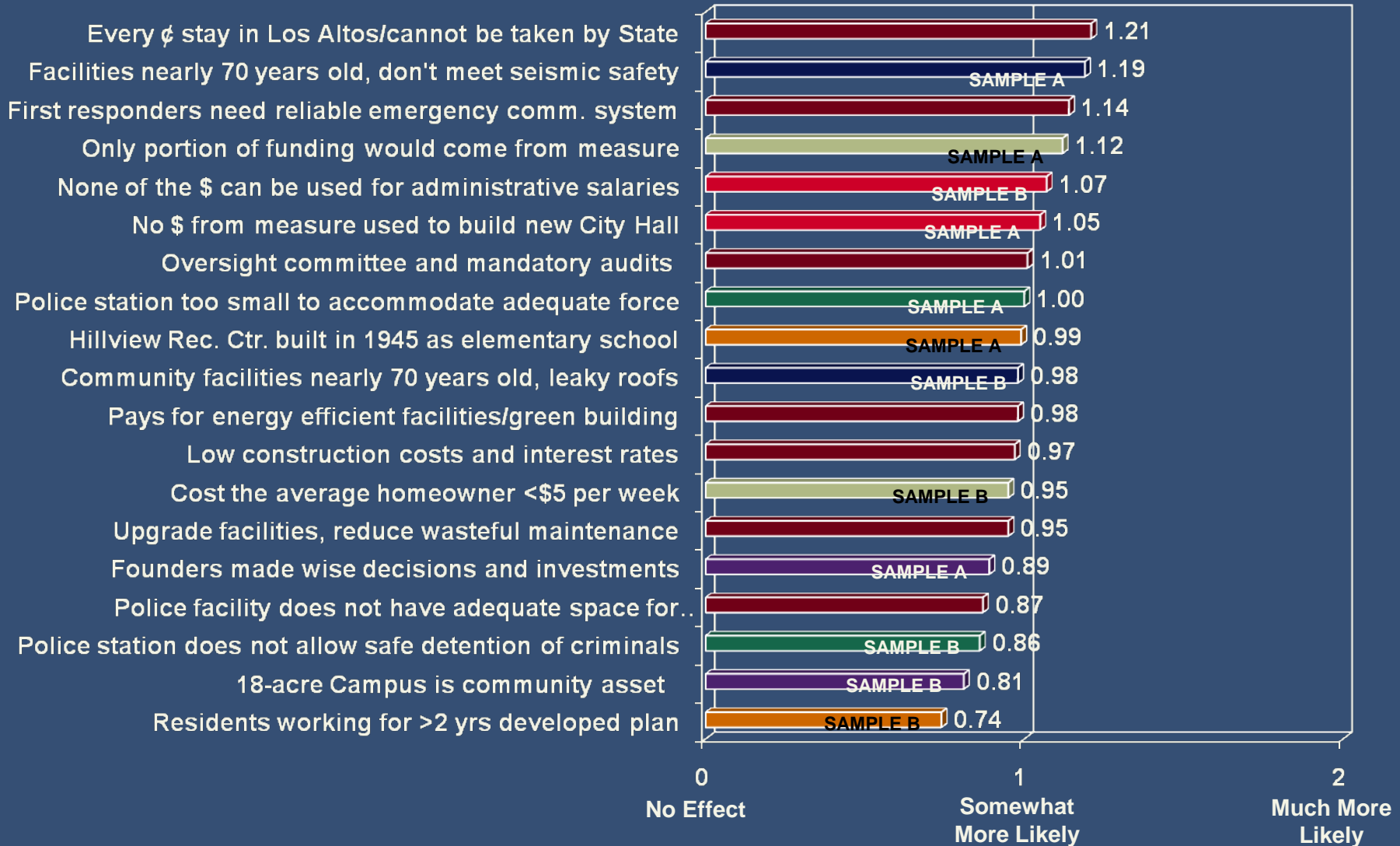
August 2012 Mail Ballot Plus Supplemental (n=404)



Features of the Measure (n=404)



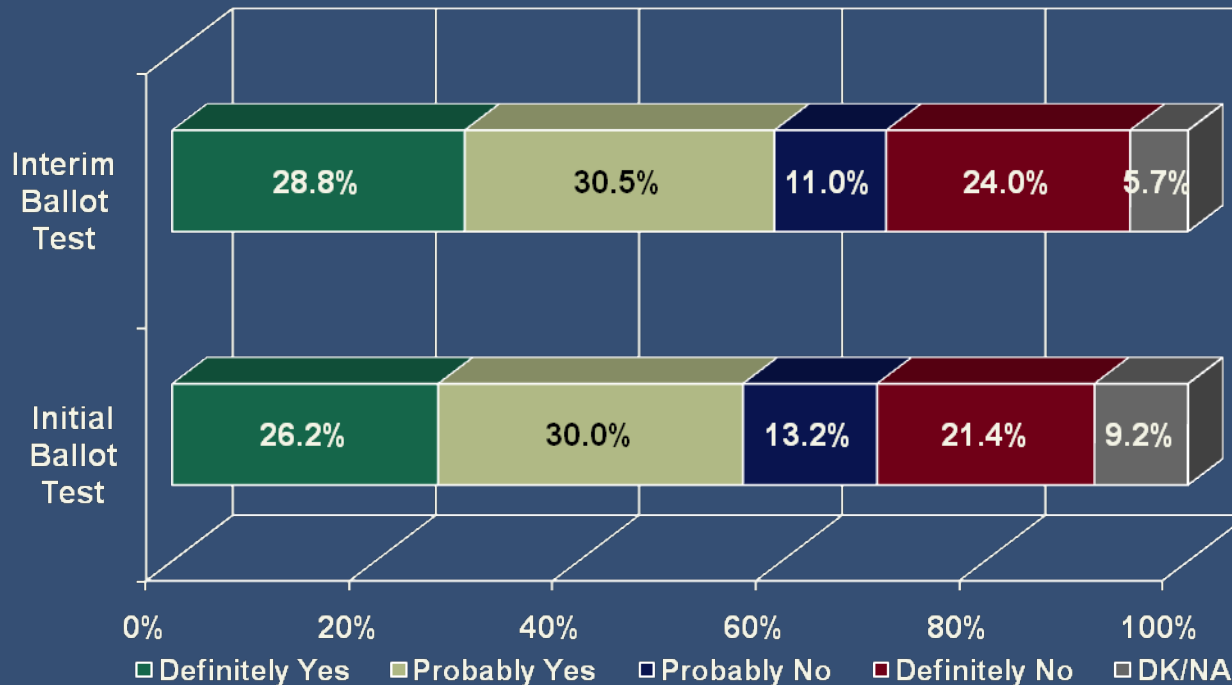
Influence of Supporting Statements (n=404)

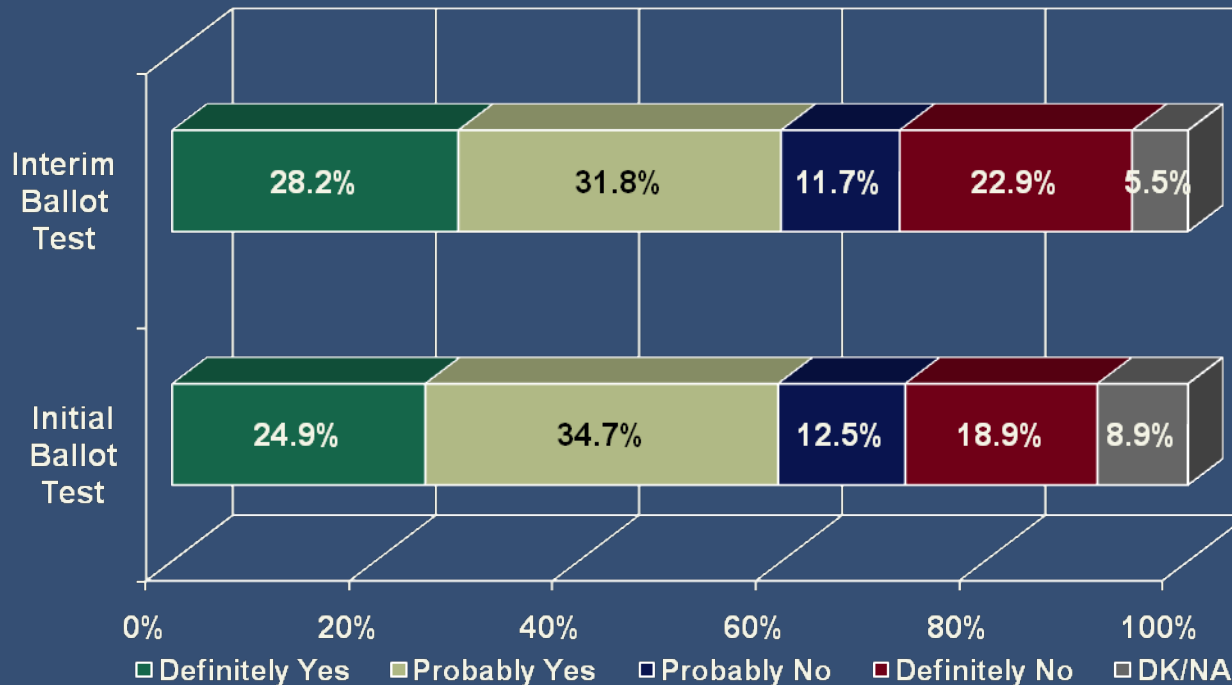

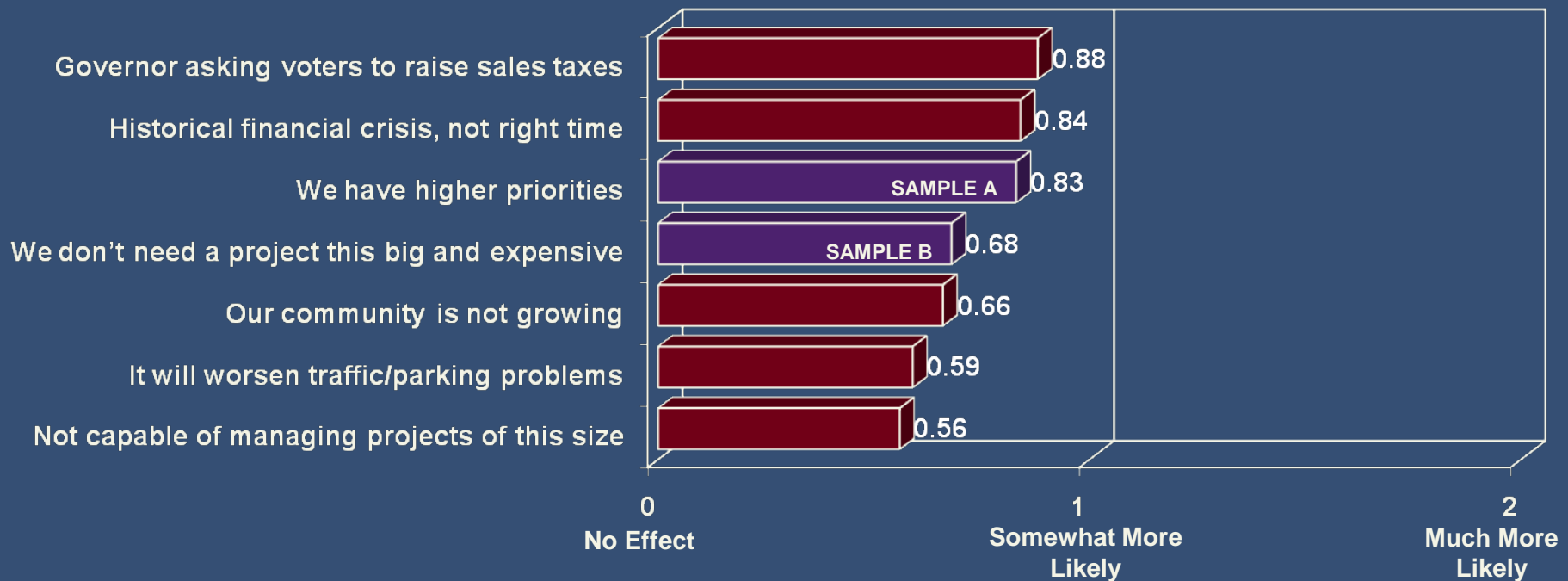

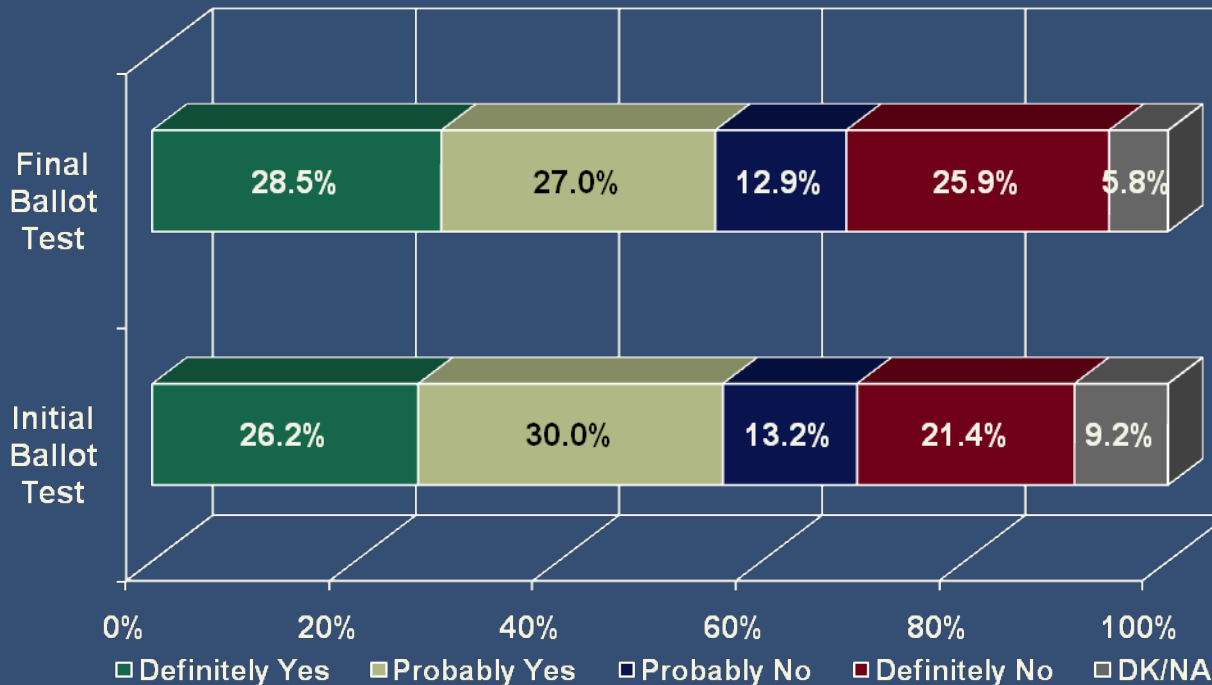
