8. Ordinance No. 2017-433: Larkellen Lane Single-Story Overlay District: Introduce and waive further reading of Ordinance No. 2017-433 adding Section 14.88.710 to Title 14 of the Municipal Code adopting the Single-Story Overlay (R1-S) District regulations

Councilmember Bruins recused herself due to a potential financial conflict of interest (owns property within the proposed overlay), and stepped down from the dais and left the chamber.

Planning Services Manager Dahl presented the report.

Mayor Prochnow opened the public hearing. There was no one wishing to speak. Mayor Prochnow closed the public hearing.

#### **DISCUSSION ITEMS**

11. <u>Downtown Vision – Future Scenarios</u>: Concur that the three draft future vision scenarios should be finalized and used as tools to engage the Community in the development of a Vision for Downtown Los Altos and for the fiscal analysis

Mayor Prochnow recused herself due to a potential financial conflict of interest (owns property within the Downtown), stepped down from the dais and left the chamber. Vice Mayor Mordo conducted the meeting.

Community Development Director Biggs introduced the item and Debbie Rudd, David Javid, Scott Martin and Bill Lee presented the scenarios.

# Public Comments

The following individuals provided public comments: Kim Cranston and Los Altos residents Pat Marriott, Richard Clark, Roberta Phillips, Abigail Ahrens and Anita Enander.

<u>Direction</u>: Councilmembers generally provided direction on the draft scenarios including the following: 1) remove the potential Los Altos Community Investments development and the potential public plaza on Parking Plaza 7; 2) add a fourth scenario which <u>is aspirational and</u> incorporates ideas not previously discussed and <u>or</u> considered; 3) modify Scenario One to reflect existing zoning regulations; 4) add more opportunities for housing; 5) add 100% low-income and/or senior housing; 6) remove the movie theater; and 7) consider mechanical parking systems.

Vice Mayor Mordo recessed the meeting at 9:27 p.m. The meeting resumed at 9:33 p.m.

Mayor Prochnow returned to the dais and resumed conducting the meeting.

9. <u>Professional Services Agreement: Hillview Community Center Redevelopment, Project CF-01002</u>: Authorize the City Manager to execute a professional services agreement between the City of Los Altos and Noll & Tam Architects and Planners in an amount not to exceed \$2,804,597 for design services for the Hillview Community Center Redevelopment, Project CF-01002

Public Works Director Chan introduced the item and Janet Tam of Noll & Tam presented a background on Noll & Tam.

Councilmember Lee Eng expressed concerns with authorizing the execution of the contract without seeing the contract and scope of work prior to authorization.

Action: Upon a motion by Vice Mayor Mordo, seconded by Councilmember Bruins, the Council authorized the City Manager to execute a professional services agreement between the City of Los Altos and Noll & Tam Architects and Planners in an amount not to exceed \$2,804,597 for design services for the Hillview Community Center Redevelopment, Project CF-01002, by the following vote: AYES: Bruins, Mordo, Pepper and Prochnow; NOES: Lee Eng; ABSTAIN: None; ABSENT: None.

10. <u>4880 El Camino Real – Elevator Tower Height Waiver</u>: Continue the hearing to a specific future date

Action: Upon a motion by Vice Mayor Mordo, seconded by Councilmember Bruins, the Council unanimously continued the hearing to September 26, 2017 at the request of the applicant.

3. <u>City/Cupertino Union School District Schools Issues Committee membership</u>: Expand the membership of the City/Cupertino Union School District Schools Issues Committee to include two representatives from the City of Sunnyvale

Councilmember Bruins opposed adding representatives from Sunnyvale and favored scheduling meetings between representatives of the three agencies as needed.

Action: Upon a motion by Councilmember Lee Eng, seconded by Councilmember Pepper, the Council expanded the membership of the City/Cupertino Union School District Schools Issues Committee to include two representatives from the City of Sunnyvale, by the following vote: AYES: Lee Eng, Pepper and Prochnow; NOES: Bruins; ABSTAIN: Mordo; ABSENT: None.

4. <u>Resolution No. 2017-33: Open Government Policy</u>: Adopt Resolution No. 2017-33 adopting the amended Open Government Policy

Councilmember Bruins expressed support modifying the Resolution to allow the Community Development Director to grant waivers to the requirements for story poles rather than the Council and to have appeals heard by Council.
