Resolution No. 2018-10: City Hall HVAC System Upgrades, Project CF-01007 (04-08A) acceptance: Adopted Resolution No. 2018-10 accepting completion of the City Hall HVAC System Upgrades, Project CF-01007 (04-08A); and authorized the Public Works Director to record a Notice of Completion as required by law.
- 6. <u>Contract Amendment: Structural Reach Replacement, Project WW-01002</u>: Authorized the City Manager to execute an amendment on behalf of the City with Bellecci & Associates in the amount of \$71,723 to provide additional consulting and inspection services as required by the Streambed Alteration Agreement that was issued by the Cal. Dept. of Fish and Wildlife for the Structural Reach Replacement, Project WW-01002.
- 7. <u>Contract Change Order: Traffic Signal Control Upgrade, Project TS-01049</u>: Authorized the City Manager to execute Change Order #1 for the P.O. #C2018115 to procure traffic signal coordination software Synchro Green in the amount of \$156,800 from Trafficware Group Inc. for the Traffic Signal Control Upgrade, Project TS-01049.
