Please consider removing the SROs from the high school and replacing them with alternate support structures for the students.

I am a parent and resident of Los Altos for the last 16 years and have also lived in this town from 1984-1991. I am writing to you today to support the elimination of SROs from Los Altos High School. It's clear from research and more importantly the testimony of dozens of current and graduated Los Altos High School students that the presence of SROs is not working.

I support the conclusion of the Los Altos Citizens' Police Task Force.

- Eliminate presence of SROs and Reallocate funds from SRO's to counseling, restorative justice, and other student services is vital to the well being of our students.
- -SROs, police or security
- officers that are called into a school should not be involved in school discipline issues. They should only be responsible for responding to serious criminal law matters where there is a real and immediate threat of serious physical injury or where it is mandated by law that such offenses be referred to the criminal justice system
- Make the police officer feedback process more welcoming and transparent.
- Implement a method to file complaints against police officers online, and to allow for complaints to be made to an independent third-party auditor. Currently, complaints against the Los Altos Police Department are filed to the department itself. No data kept by police nor district on the success/effect of SRO program. This is unacceptable and there must be a record and police need to be held accountable.

A number of students of color have had negative experiences both off and on-campus with Los Altos police. Seeing armed police officers in what should be a safe place of learning is 'triggering" for students who already have had negative encounters with police off-campus. I encourage the Council to adopt the Task Force recommendations.

The police fill a critical role in our society to maintain peace and order. To enable them to fill that role, the government grants them a monopoly on the use of violence. It is no wonder that such an awesome responsibility should come with strict scrutiny and oversight from the citizens. To preserve our freedoms, this monopoly on violence should be constrained to the minimum set of circumstances possible, and it should be transparent to all.

The SRO program lacks a common set of goals, and as such, has no data showing it is meeting those goals. Greetings City Council Members,

I'm Marie and have owned a home in Los Altos since 1976, and have lived here since then except for a 10-year period in the 1990's when we lived in Prunedale, Monterey County.

I write to encourage you to approve both police reform task force recommendations tonight based on my experiences as described here.

Re: canceling the SRO program at LAHS. While in Monterey County, I served for seven years on the North Monterey County (NMC) Unified School District Board of Trustees. At one point, we were concerned about gang activity in Salinas migrating north to our area. We considered establishing a police presence (potentially with metal detectors) on the campus of NMCHS, where my son was a student at the time. Ultimately we adopted the research-based recommendation of the school administration that the best way to ensure student safety and prevent undesirable behavior was for faculty and staff to establish and maintain **genuine relationships** with each and every student (1,200 at that time). It worked, and many students were also provided needed resources by those caring educators! By the way, it was during this period that I also learned about the limited, at best, effectiveness of D.A.R.E.

Re: *making it easier to file complaints about police*. For twelve weeks, an African-American woman lived with us while completing a fellowship at the David and Lucile Packard Foundation, my employer at the time. While my family and I have had nothing but positive experiences during our few interactions with LAPD (we are white), Carla arrived home on more than one occasion reporting that she'd been stopped by LAPD simply for "driving while black". Accordingly, the reports of our neighbors of color ring true, and anything that makes it easier to capture their experiences formally is a good thing.

More generally, I believe that when the Council appoints a task force/commission and that body takes its work seriously and does it thoroughly, the Council owes them the duty of adopting their recommendations unless those are wildly off base - which these two most certainly are not.

Thank you for your consideration and for your service to our community.

Re: Citizens' Police Task Force Recommendations

Honorable Members of the Los Altos City Council:

As a resident of Los Altos, I'm writing to ask the city council to approve the task force recommendations in their entirety without delay.

I specifically support the recommendation that the School Resource Officer (SRO) position be **removed** from Los Altos High School.

The task force worked very hard and diligently to craft these solid recommendations. The task force also reflected a diverse segment of Los Altos, both in racial diversity and age diversity.

As 2020 has shown us, these are voices we often don't hear from in city council.

We heard loud and clearly - at the town hall that many residents of color have concerns with policing in the town.

Residents of color want to feel safe and they want that extended to their children at Los Altos High School.

School Resource Officers are police officers. They are not counselors or social workers.

The intended role of the SRO is very loosely defined and there is no clear data on the effectiveness of the SRO's presence within the Los Altos High School Community. The school and police disagree on its main aim, and students are not aware of the "resources" the officer is supposed to provide for them.

Schools are designed to be community hubs that are welcoming, supportive, and nurturing.

Police presence in a school environment does not fully support a welcoming, supportive, or nurturing environment.

Everyone does not feel comforted or safe when they see a police officer.

For many, a police presence causes stress, tension, and anxiety.

Suggesting to students that they can go to an SRO for counseling (when the SRO can report their conversations as part of a criminal investigation) is ineffective, damaging, and can lead to negative consequences.

Even the <u>American Federation of Teachers</u>, one of the country's largest teacher unions, passed a resolution calling for the separation of school safety and policing.

I started my career as a high school teacher in 1994 (in Illinois). Each building I worked in had an SRO. The SRO roamed the halls and left an intimidating wake amongst the students. Many of the students complained that the SRO's presence made school feel punitive. Some students felt like the SRO was monitoring them for bad behavior – when they were just being teenagers. They did not feel supported.

I have worked in schools in 3 different states – and that energy has not shifted much from 1994 until now. The SRO position is not value added for students.

There needs to be alternative support structures provided for our students.

The focus should shift away from having an SRO - and move towards restorative justice programs, having mental health counselors available, and other support staff on hand to support the student community.

The SRO job description states, "The SRO balances the role of a law enforcement officer with that of a counselor and an educator and is also trained as a certified D.A.R.E. instructor to handle public speaking events. The SRO is also highly trained in internet predator safety and cyber bullying."

Nowhere in the job description does it require the SRO to have specific diversity/inclusion training or exposure to culturally responsive communication. This is very problematic and puts a segment of the Los Altos High School community at a disadvantage – and causes great harm.

Eliminating the SRO position will show a good faith effort by the Members of Los Altos City Council to foster and maintain the City of Los Altos as a great place to live and to raise a family – for all of our citizens.

Until the SRO position can have clear and measurable objectives – this position needs to be removed.
