I would like to express my support for the safe storage ordinance on the agenda for the 9/14 meeting.

Nearly every day in this country one small child unintentionally kills himself or another child after finding an unsecured firearm typically in their home. Every day on average, two teens die of suicide using an unsecured firearm from their home or a relative's home. Unsecured firearms are also easily stolen in home robberies where they then become crime guns for criminals. Finally, 80% of school shootings are done by a student or former student of the school, using an unsecured firearm obtained from their home or a relative's home.

Many cities in the Peninsula have passed Safe Storage ordinances and I urge the city council to add Los Altos to the list.
