To Los Altos Council Members——

We have been residents of Los Altos Hills adjacent to the Redwood Grove for over 50 years, and have greatly enjoyed the proximity and access to the park. However, the pathway from the end of Fremont Road into the park has been a challenge for all this time, and repeated requests for improvement have been dismissed. I was thrilled several years ago when the towns of Los Altos and Los Altos Hills reached an agreement to work together for creating a safe pathway in this area, but have been disappointed that to this date nothing has been done.

Los Altos has been working diligently to clean the debris in the park, as well as to create a safe and accessible pathway system. I very much appreciate all the work that has been done, and continues on a regular basis, to keep these walkways maintained. However, it is definitely time to address the access from Fremont Road. The informal paths that have been used over the years are quite dangerous, especially during rainy winter months. The Pathways Committee of Los Altos Hills has tentatively proposed an alternative path which could resolve some of these issues.

I strongly urge you to continue to work with Los Altos Hills and the Pathways Committee to resolve this very long-standing issue. It will provide great benefits for all the neighbors in both Los Altos and Los Altos Hills.
