Good morning,

This email is being sent to the City Council and all City Commissions. Thank you for your continued service to the City of Los Altos. We wanted to take this opportunity to send an email with a few reminders regarding your and the City's obligations under the Brown Act. Please remember that as officials of the City, each of your respective legislative bodies are subject to the requirements of the Brown Act.

- All Council/Commission/Committee business must be conducted at a properly noticed meeting. As staff, we will ensure that meetings are properly notice. As Council/Commission/Committee members, please make sure that you are not conducting business outside of these meetings. Subcommittee work is fine, but make sure not to include a majority of your body either at the subcommittee meeting or through subsequent communications
- You are required to limit discussion at meetings to those items on the agenda. Do not discuss items that are not on the agenda
- If you have documents that you are planning to bring to a meeting for the body to consider, please send those to the staff ahead of time so that staff can have copies for each member of the body as well as for the public. Also, staff will make sure that those documents are posted online so that any member of the public can see and review them. The Brown Act mandates that if a member of a body shares documents with a majority of that body at a public meeting, that those documents be made available to the public. In general, a member should not be distributing materials to a majority of a legislative body outside of a public meeting as it raises Brown Act risk
- Please be careful with your communications by email with other members of your body. Remember, don't reply all to emails sent to the entire body and avoid stating opinions in email as emails can be forwarded to other members leading to a potential Brown Act violation
