Local Government Commission Leaders for Livable Communities

AB 965 Levine

Would direct the Department of Housing and Community Development (HCD) and the California Building Standards Commission (CBSC) to propose electric vehicle charging standards for existing non-residential buildings by July 1, 2024. It also requires HCD to consider certain factors in developing electric charging standards for existing multifamily buildings.




AB 897 Mullin

Would Direct the Office of Planning and Research (OPR) to facilitate the creation of regional adaptation collaboratives, to create standards for regional climate adaptation plans, and to support implementation of climate adaptation plans. It would also encourage integration with other programs such as the Federal Emergency Management Agency (FEMA) hazard mitigation program.



AB 1395 Muratsuchi

Would establish policy of the state to reach net zero greenhouse gas (GHG) emissions no later than 2045.





SB 617 Wiener

Requires local governments to implement online, automated permitting for residential solar systems and would require the CEC to provide grants to assist the implementation of such systems.





Online Solar Permitting

The budget bill, **SB 129**, appropriates \$20 million to the California Energy Commission (CEC) to make grants to local governments to implement online solar permitting.



Clean Transportation

Allocates \$3.9 billion over three years to reduce emissions from the transportation sector, which accounts for nearly 50 percent of California's annual emissions. This package provides funding for clean cars, trucks, and buses, infrastructure programs, and ongoing funding to ensure low-income Californians can afford to own a clean car.

Climate Resilience Package

The Governor and Legislature have agreed to spend \$3.7 billion over the next three years on climate resilience and budget bill, **SB 129**, appropriated \$440 million for fiscal year 2021-22 for this purpose. Additional funding allocations are contained in **SB 155** and **SB 170**.
