# 4. <u>Tax-Exempt Loan RFP</u>

# 5. Year End Close and Audit Updates

Finance staff is working with our consultants and auditors to complete our year end close and CAFR. There will be a note disclosure on our Financial Statement regarding the number of pending litigations involving the City.

# 6. October 13 Council Study Session - Financial Status Update

Finance Director, Mr. Sharif Etman will present to the Council the current budget and fiscal position of the City. Mr. Etman notes that the most pressing fiscal issue threatening the city's financial well-being are the ongoing litigations.

# 7. Other Staff Updates

Financial Services Manager, Ms. Thuyet Dang reports the new city-wide financial software, Financial Enterprise is an improvement from the City's previous software system. Ms. Dang and her staff are updating City policies and procedures to better serve this new system. Along with working with Financial Enterprise, her staff are working with vendors on the ETrakit system to improve online services for the City. Currently, the division has two open positions and one staff on leave.
