2. <u>11-H-02 – 170 Formway Court</u>

Staff Liaison DAHL presented the staff report and answered questions from the commissioners.

The Commission voiced support for the overall concept of the project, but raised concerns about losing the French doors, which appeared to be original, and noted that the addition should be pushed back in order to provide a better connection with the historic structure. A Commissioner also raised concerns about the joint between the existing roof and proposed addition and potential drainage issues. By setting the addition back from the existing front wall, the addition would better differentiate from the original structure and minimize the loss of the original wood rafter tails.

MOTION BY COMMISSIONER MARFATIA SECONDED BY COMMISSIONER KREISMAN, to approve the addition with the following condition:

• Set the addition back by more than two feet in order to remove the conflict with corner and differentiate new wall from existing wall.
