There are a few staffing changes taking place with in the library. During the month of March the library held 10 programs for adults and two for teens. There are 11 programs planned for April which include a variety for both teens and adults. There were a total of 35 programs for children during the month of March as well. In addition to regularly scheduled story times, there were some special programs provided as well such as Afternoon at the Movies and the Cat in the Hat event. Along with regular preschool and bedtime story times, upcoming programming includes: SciFi Book Club for 7th and 8th graders, Afternoon at the Movies, Mad Science programs, and "Spring into Book Club" for 4th-6th graders.

- 1. Senator Simitian has introduced SB 156 California Reading and Literacy Improvement and Public Library Construction and Renovation Bond Act of 2008. If passed by the State Legislature and signed by the governor, this Proposition could appear on a ballot as early as June 2008.

Additional focus was on fundraising for the expansion and how to go about asking Council's permission for continued pursuit of expansion.

2) Needs Assessment

Commissioners discussed the desire to conduct a needs assessment of the Library. Roy Lave of the NCLA board spoke on behalf of NCLA. He indicated that he would go back to the board and ask about funding a needs assessment in order to move forward with expansion details.

COMMISSIONER THURBER MOVED to ask NCLA to fund the cost of a needs assessment. THE MOTION WAS SECONDED BY COMMISSIONER SMITH AND PASSED UNANIMOUSLY BY VOICE VOTE.

Commissioner Smiths' presentation to Council regarding the Brain Fuse – tutoring Online Program was very successful. Commissioner Struthers also had a successful presentation to the Town Council of Los Altos Hills about the Brain Fuse program.
