RESOLUTION NO. 2008-32

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LOS ALTOS REGARDING THE PUBLIC HEARING AND THE ADOPTION OF THE CITY'S 2008-2009 SOLID WASTE COLLECTION RATE SCHEDULE AND OVERRULING THE PROTESTS RECEIVED THEREON.

WHEREAS, the City of Los Altos Public Works Director provided at least forty-five days' (45) notice of the time and place of the public hearing by mailing notice of such hearing, postage prepaid, to all solid waste collection rate payers and owners of property subject to the City's solid waste collection rate schedule ("Mailed Notice"); by causing the publication of the Mailed Notice in a local newspaper; and, by posting a copy of the Mailed Notice and said Mailed Notice on the official bulletin board customarily used by the City Council for the posting of notices, which shall be completed not less than once a week for two (2) successive weeks prior to such hearing; and

WHEREAS, on April 11, 2008, the Mailed Notice was sent to all solid waste rate payers and owners of property subject to the City's solid waste collection rate schedule. Said Mailed Notice stated that a public hearing on this matter would be held by the City Council on May 27, 2008, at 7:00 p.m., in the City Council chambers, Los Altos City Hall, located at One North San Antonio Road, California, at which hearing the City Council would hear any and all protests in relation to the City's solid waste collection rate schedule and act upon any and all protests and objections; and

WHEREAS, all solid waste collection rate payers and owners of property subject to the City's solid waste collection rate schedule were thus properly notified and given the opportunity to file with the City Clerk written protests at any time prior to the close of the public hearing; and

WHEREAS, on May 27, 2008, the City Council held a duly noticed public hearing, at which hearing the City Council considered all testimony and evidence, including any written protests previously submitted, and all persons desiring to submit written or oral testimony regarding the City's solid waste collection rate schedule or otherwise desiring to be heard on the matter.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Los Altos hereby finds and authorizes the following:

1. On April 11, 2008, the City sent 9,334 Mailed Notices to all of the solid waste collection rate payers and owners of property subject to the City's solid waste collection rate schedule.

By the close of the public hearing on May 27, 2008, the City received a total of 51 written and oral protests; therefore, the property owners of a more than a majority of the owners of the parcels subject to the City's solid waste collection rate schedule did <u>not</u>, at or prior to the time fixed for said hearing or during said hearing, file written protests against any said solid waste collection rates.

2. All protests and objections of any kind, be they written or oral, are hereby overruled.

3. The City's 2008/2009 solid waste collection schedule attached hereto as "Exhibit A" and incorporated herein by this reference, are hereby adopted by this Resolution No. 2008-32.
