

RESOLUTION NO. 2016-11

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LOS ALTOS
APPROVING ENGINEERING AND TRAFFIC SURVEYS AT 26 STREET
SEGEMENTS IN LOS ALTOS**

WHEREAS, the California Vehicle Code Sections 627, 22357 and 22358 and the California Manual for Uniform Traffic Control Devices allows local agencies, based on an engineering and traffic survey, to increase or decrease speed limits; and

WHEREAS, the California Vehicle Code and the California Manual for Uniform Traffic Control Devices requires that local agencies re-evaluate non-statutory speed limits every five (5), seven (7) or ten (10) years, using an Engineering and Traffic Survey; and

WHEREAS, on September 10, 2013, City Council adopted the current Engineering and Traffic Survey which defined the current speed limits in the City.

NOW THEREFORE, BE IT RESOLVED, that the City Council of the City of Los Altos hereby approves Speed Limits for the following street segments:
