ITEMS FOR CONSIDERATION/ACTION

1. Receive information and announcements from City staff

Staff reported on the following: the installation of *Archimedes Goose*, the presentation of *Floret* to the Parks and Recreation Commission on November 9, 2016, and the deadline for the Public Arts Master Plan Requests for Proposals on October 28, 2016.

2. Approve minutes of the meeting of September 29, 2016

7. Discuss potential art installations for Veterans Community Plaza

Commissioners discussed potential installation ideas.
