PUBLIC COMMENTS

Action: Upon a motion by Commissioner Ellickson, seconded by Commissioner McBirney, the Commission unanimously recommended installing *Alegria* in Village Park (to replace *Magic Garden*), *Mutha Hen* at the corner of State Street and Third Street, and *Reverse Prometheus* on the Civic Center campus next to the walkway between City Hall and the Library and adjacent to the San Antonio Road sidewalk.

- 5. <u>Artistic Bike Rack Design Competition</u>: Review submissions and discuss next steps for the second Artistic Bike Rack Design Competition
 - Commissioners discussed the entries for the second Artistic Bike Rack Design Competition and potential colors for the racks.
- 6. <u>Education and outreach</u>: Discuss opportunities to provide education and outreach to the community regarding public art
