### How to apply continued

• Completed applications and documents to verify income, residence and age must be presented in person by all applicants in a household at the appointment with the Finance Department located at City Hall.

Call 650-947-2615 for an appointment to turn in all completed materials and review eligibility.

### Scholarship logistics

- Maximum Scholarship of \$200.00 per household regardless of number of members in the household per fiscal year (July 1 June 30).
- Unused scholarship funds are forfeited on June 30.
- Applicants must re-apply each year.
- · Scholarship funds are not paid directly to the individual.
- Scholarship funds must first be used to purchase a Senior Center Membership for each adult over the age of 50 participating in Senior Center programs. (\$26.00/per person).
- Scholarship funds may only be used toward programs administered by the City of Los Altos Recreation Department Senior Center and may not be used for purchasing Bart tickets, raffle tickets or See's Candies gift certificates.

### Registration logistics

- Senior Center program descriptions may be found by looking in the *Spotlight* the Senior Center's bi-monthly newsletter. The *Spotlight* may be viewed online at losaltosrecreation.org or picked up at the Senior Center.
- To register for Senior Center programs after the initial appointment to verify eligibility, all scholarship recipients must fill out the City of Los Altos Senior Scholarship Program Registration Form and turn the completed form into Senior Center staff via mail, email, fax, post office or dropping by the City of Los Altos Senior Center (97 Hillview Avenue, Los Altos, CA 94022, Room 10) by the first day of the coming month.
- Once the completed registration form has been turned in, staff will register and email a
  registration confirmation or if you would like a receipt mailed through the post office please
  bring a self-addressed stamped envelope with your registration form.

### Scholarship completion

• Each household will receive a City of Los Altos Senior Scholarship Program Evaluation Form either after the household has spent its funding or after June 30. The Senior Scholarship Program is evaluated each year so it is important that one completed evaluation form per scholarship recipient in a household is completed and returned to Senior Center Staff.

### Advisory Council Minutes Santa Clara Senior Center April 2<sup>nd</sup>, 2012

### Call to Order

The meeting was called to order by Chairperson Bob Lindley at 12:30 PM. A quorum was present.

Approval of Agenda and Minutes

Connie did not have items for the Member's Report so she asked for it to be removed from the agenda. Otherwise the minutes and agenda were approved as presented.

Legislative Committee

Connie noted the Legislative committee is working on setting up a meeting room at the Santa Clara Senior Center for future meetings. She recently attended a meeting of the CSL Bay Area Caucus. The group is working on a report showing where and when bills will be heard in Sacramento. This should be extremely helpful in effectively advocating for senior issues.

### Transportation Committee

Nominating Committee

A nominating committee was formed to help find a Chair, Vice-chair, and Secretary for the 2012-2013 Advisory year. Bob Lindley and Connie Langford volunteered to form the committee.

**CSL Legislative Session** 

Bob Jaffee indicated members should review the CSL minutes for the latest update on CSL news. Members are reminded to donate to Code 402 to help support the CSL. Austin discussed the process of having his bill pass by a margin of 11-1.

Program - COASV Information & Assistance Service

Crystal Shafiabady and Daniel Lucero arrived from COASV's Information & Assistance program to talk about some of their activities. The top 5 calls received by the I&A call center are for home care, insurance counseling, caregiver support, housing, and food. COASV staff uses an internal referral database to keep information on upcoming events, as well as available services in the community. This database is tied to the Online Resource Database, which has been available since January 2011. Users can search the ORD by keyword or use filters. Increasing font size is an upcoming feature.

When I&A staff provide a referral, staff makes a follow-up call 3 weeks later. At this time, the staff member can gauge if the referral was successful or not, and if not, record an unmet need. This helps COASV staff evaluate the unmet needs of clients. Staff holds weekly 30 minute meetings to discuss newly available service and to share customer service tips.

COASV has also revised our Outreach presentation, which demonstrates the services offered by COASV. Voice of Ages is a new newsletter distributed quarterly in both print and e-mail form. The difference between I&A and 211 is that I&A is focused exclusively on senior services. I&A has one bilingual (Spanish) speaker on staff but frequently uses language line to bridge language barriers.

### Old Business

Lessie James discussed a foreclosures audit showing that 84% of foreclosures filed are fraudulent. The Santa Clara County DA may have enough evidence to prosecute fraudulent foreclosures but has not done so to date. The states recently reached a settlement with major banks over some foreclosure damages, but that does not eliminate criminal prosecution.

The City of San Jose decided to issue CDBG funds to organizations in chunks of \$100K. \$400K may be newly available to senior programs in the city, with funding coming from the general fund. The membership approved a letter to be sent to the Mayor and City Council requesting the release of \$400K of general funds to support senior services.

Members asked about COASV's printed directory and if there were any plans to bring it back. Steve Schmoll, COASV CEO responded that the printed directory cost between \$70-\$120K to print and was too costly and out of date to bring back. Seniors can call into I&A and have a printed referral sent to them by I&A staff. A suggestion was made to post a printable, PDF version of the COASV printed directory available online. Manuel Altamirano, COASV COO, said this was not a good idea. Seniors calling into COASV can get access to other services they may not be aware of just from a printed directory. Members responded that seniors should have the right and ability to get information in the method they are most comfortable with. Manuel responded that the online-only version of the directory is part of COASV's coordinated marketing & outreach plan, and is all about leveraging resources. Members responded that a printed directory can help seniors who have a language barrier, as a printed resource may be more reliable or easy to use than calling in to someone who doesn't speak their language.

### Shawna Reeves, Project Sentinel

Shawna came to update the group on her new work with Project Sentinel. You can reach Project Sentinel at <a href="www.housing.org">www.housing.org</a> or <a href="mailto:sreeves@housing.org">sreeves@housing.org</a>. Project Sentinel handles a variety of housing issues such as foreclosure, tenant-landlord disputes, and others. Shawna focuses on housing discrimination, particularly in regards to seniors. It is illegal to deny housing to an individual due to age, disability, or other reasons. Regarding home modifications, the renter must be able to pay for the cost of making a required home

modification, but the landlord is required to accommodate the renter and make the modification.
