1. Teen Program Report

Staff Karney presented survey results from Junior High surveys conducted in June 2006. The major points of the results indicate that most teens do not know about the Underground or the Youth Commission.

4. Skate Park Project Update

Chair Saliba reported that City Council approved the Skate Park Project and placed it on an Unscheduled CIP list. Staff explained to commission how the CIP process works.

Staff reported that the LAYC hall building capacity was re-evaluated over the summer and the new capacity is 525. Staff also reported that LAYC dances would go back to their old format of all members being able to attend each dance.

6. Personnel Committee Review Update

Staff Legge presented the Personnel Committee Review recommendations as it related to the conduct of all City committees and commissions.

7. Art and Wine Festival

Commissioners who volunteered at Art and Wine Festival discussed the event and the work they performed. Staff Legge announced that the Los Altos Village Association donated \$200 to the teen programs on behalf of the Youth Commission. How the money can be spent on teen programs will be reviewed and recommended at the next meeting.

8. Community Picnic

Staff announced that Jennifer King would be coordinating the dodgeball tournament with the youth Commission. A special meeting will be set up to discuss the dodgeball tournament, review the Bocce Ball rules and discuss other volunteer opportunities at the Community Picnic.
