BUSINESS

Skate Park Project Draft Presentations

The Commission reviewed the revised power point display of the commission's research, findings and recommendations to develop a skate park in Los Altos. The commission discussed various improvements to the presentation that included the following:

- Change date of PARC meeting
- Location Criteria update with information on accessibility to parking and proximity to concessions. Consider proximity to schools. Update pay phone information.
- Insert missing pictures.
- Include background survey information.
- Explain Target Group age and skate level.

The Commission discussed the importance of considering the hours of operation during the process. The Commission further recommended that the parking lot area that was used for the temporary skate park at Hillview, be measured for reference.
